There have been a few changes within the city of Heidelberg this past year. While many of the changes can be found on the city website at cityofheidelbergmn.com, we feel it is necessary to follow up with a letter highlighting some of those changes.

The City of Heidelberg has a new phone number which is (952) 290-0567. Please write this number down in a convenient place for future reference. If you reach a voice message when you call, be sure to leave your name, phone number, as well as the nature of your call. You will receive a prompt response.

In March, the Council amended Chapter 4 of Heidelberg's City Building Code: Building Code and Construction Licensing (Ordinance No. 2-2019), adopting future amendments made to the State Building Code, keeping our ordinance up-to-date remaining within the parameters of state law. This information is available for review on the city website at cityofheidelbergmn.com.

As many of you already know, in March, Corey Block came on as our City Building Inspector. His information can be found on the Heidelberg city website cityofheidelbergmn.com. On the main page you will find a building icon labeled "New Building Inspector Info" in the upper right-hand corner. Clicking on that icon brings you right to his website. Corey's website is cblockinspections.com. On his website you will find the tab titled "Heidelberg". When clicked on, it will bring up a list of forms and permit applications that are specific to our city. Please note that a building permit must be obtained **before** you start your building project. Contact Corey at (507) 420-6574 or cblock@frontiernet.net. He and the city administrator will help guide you through the permit application process to obtain your building permit.
